In consideration of participating in Combat Archery, I affirm that I comprehend the nature of this activity. I certify that I am adequately qualified, in good health, and in suitable physical condition to engage in such activity. I acknowledge that should I perceive any unsafe conditions during the event, I will promptly cease participation.

I fully comprehend that this activity carries the risk of severe bodily injury, which may result from my actions, the actions or inactions of other participants, the event's conditions, or the negligence of the individuals or entities listed below ("releases"). Additionally, there may be other risks not presently known or reasonably foreseeable. I willingly accept and assume all such risks and responsibility for any losses, expenses, or damages I may incur due to my participation in the activity.

By signing this agreement, I release, absolve, and agree not to bring a lawsuit against Funtime Kids Parties, its administrators, directors, agents, officers, volunteers, employees, fellow participants, sponsors, advertisers, and if applicable, owners or lessors of the premises where the activity occurs (collectively referred to as the "RELEASES"), for any liabilities, claims, demands, losses, or damages caused, or claimed to be caused, either wholly or partially, by the negligence of the RELEASES or otherwise, including any negligent rescue operations. Furthermore, I agree that in the event I, or anyone on my behalf, files a claim against any of the RELEASES, I will indemnify, protect, and hold harmless each of the RELEASES from any expenses, attorney fees, liabilities, damages, or costs incurred as a result of such a claim.

This list serves as an essential guide to ensure your readiness to comply with our regulations upon arrival at any of our sites. Before all events at every location, a site-specific briefing will be provided to clarify safety protocols and rules in detail.

- Please ensure punctuality as there will be no additional time allocated for late arrivals.
- Recommended age for target practice is 6 years and above, and for combat archery, it is 9 years and above.
- A minimum of 10 players per booking is required.
- We strongly always advise appropriate footwear.
- While arm guards are provided, wearing long-sleeve shirts helps protect against bow burn.
- Players must remove any loose jewellery and cover items that may cause harm or damage equipment. Additionally, long hair must be secured.
- Avoid moving or running into the bunkers.
- Face masks must be worn continuously during gameplay, including when standing on the sideline after being hit.
- Intentional headshots are not permitted.
- Do not shoot at individuals in the safety zone, and refrain from shooting while within the safety zone.
- Avoid dry firing bows (shooting without an arrow).
- A 'hit' occurs when an arrow strikes a player or their attire, excluding headshots.
- Ricochets do not count as hits.
- No physical altercations or verbal abuse; seek a referee if encountering issues with other players.
- External bows or arrows are prohibited; only equipment provided by Funtime Archery Attack is permitted.
- Referees' decisions are final and prioritize safety and fair play. Repeated unsafe behaviour may result in time out or, in severe cases, ejection from the game.
- If there's uncertainty about any rules or queries, our knowledgeable referees are available to assist.
- Safety and security always take precedence over gameplay.
- Damages incurred due to negligence, misuse, dry firing, or overextending the draw length of a bow or arrow will incur a fine.
- Funtime Archery Attack retains the right to store and utilize the information provided in every booking.
